The Head office of the Society will be in Agra.

The objects of the Society are as follows:-

- (i) To make arrangements, suitable to the trend of the times for educating the children and Youths, Irrespective of casts or creed in various branches of education, vocation in life and profession.
- (ii) To maintain, run, expend, develop and raise institutions known as the Raja Balwant Singh College, Raja Balwant Singh Intermediate College, Raja Balwant Singh Junior High School in Agra, Balwant Vidyaapeeth Rural Institute Bichpuri, Balwant Rural Engineering Institute, Bichpuri and Raja Balwant Singh Girls Junior High School, Bichpuri (founded under the provisions of the codicil of will of late Raja Balwant Singh of Awagarh (Etah) dated 31st May 1909 and the Balwant Rajput High School trust founded in July 1915 and at present maintained and administered by the Balwant Educational Society) to the status of the highest academic educational institutions and to start and develop other educational, vocational and professional institution according to the needs of the times.
- (iii) To take measures for spreading such kind of education as contribute to the highest public good according to the needs of the times.
- (iv) To establish centres in the various parts of Uttar Pradesh for propagating the educational activities of the society, and.
- (v) To do all such other lawful acts as are incidental or conducive to the attainment of these objects.



2. Head Office:- The Head office of the society shall be at AGRA.

3. Objects:-The objects of the society are as follows:-



To make arrangements, suitable to the trend of times, for educating the children and youths, irrespective of caste or creed in various branches of education, vocations in life and professions.

To maintain, run, expand, develop and raise institutions known as the Raja Balwant Singh College, Raja Balwant Singh Intermediate College, Raja Balwant Singh Junior High School in Agra, Balwant Vidyapeeth Rural Institute Bichpuri, Balwant Rural Engineering Institute, Bichpuri land, Raja Balwant Singh Girls Junior High school, Bichpuri (founded under the provisions of the codicil of will of late Raja Balwant Singh of Awagash (Etah) dated 31st May 1909 and the Balwant Rajput High school Trust founded in July 1915 and at present maintained and administered by the Balwant Educational Society) to the status of the highest academic educational institutions and to start and develop other educational, vocational and professional institutions according to the needs of the times.

(1). To take measures for spreading such kind of education as may contribute to the highest public good according to the needs of the times.

Subject to the provisions of the Societies Registration Act, 1860, be deemed to be the members of the Society.

1. Board of Management:-

1. The Management, Superintendence and governance of the Society and all its institutions, except those provided with a separate scheme of management, shall vest in the Board of Management. The Board shall, however, have the powers to co-ordinate the activities of various institutions and evaluate their performance from time to time and advise the concerned Managing Committee to take such action as it may deem necessary. The Board of Management shall be composed of:-

- (a). The District & Sessions Judge of Agra for the time being,
 - (b). A Member from the family of Late Raja Balwant Singh Ji elected by the Board of Management.

 - (g). The Principal of the Balwant Vidyapeeth Rural Institute, Bichpuri, Agra for the time being.
 - (h). The Principal of the Balwant Rural Engineering Institute, Bichpuri, Agra for the time being.
 - (i). An alumnus of any of the institutions maintained by the Society to be elected by the Board of Management for a term of four years.
- Thirteen members to be elected by the Board of Management for a term of four years commencing from the date of appointment.

Provided that in the event of a question arising as to whether a particular person is or is not an alumnus of the institutions the decision of the Board of Management shall be final.

(2). Any member appointed under section (i) or (j) of clause (1) not attending meetings of the Board for one year, shall be deemed to have vacated his office.

(3). In case a member of the Board ~~ceases~~ or otherwise ceases to be a member of the Board, the remaining members of the Board may, within six months of the office of a member failing vacant, elect a member to fill up the said vacancy. If the elected member ceases to be a member of the Board of Management of the Society, he shall automatically cease to be a member of the Managing committees of its Institution.

vacancy being caused by the expiry of term of a member may be filled in at a meeting of the Board to be held just before the expiry of such term provided the member whose term is to expire shall not be present in the meeting at the time of consideration of that agenda item and provided also that the member so elected take office from the date of the vacancy caused.

Office Bearers:-

(i). President: The District & Sessions Judge, Agra for the time being shall be the President of the Board.

(iii). Vice-President:- The member elected by the Board under rules 5 (ii) (b) shall be the Vice-President.

(iii) Secretary :- The Secretary to the Board shall be elected by the Board from its elected members. He shall also be the Secretary of the Managing Committees of those institutions to which he is elected by the Board.

The Secretary shall keep a true and faithful record of the proceedings of all the meetings of the Board and shall, in books to be kept by him enter or cause to be entered full and true accounts of all money received and paid respectively on account of the Society.

Joint Secretary:- The Board may appoint a Joint Secretary from among its elected members. The Joint Secretary shall perform such duties, as may be assigned to him by the Secretary from time to time in writing. [Signature]

7. Meeting of the Board of Management:-

(i). Ordinarily the Board of Management shall meet atleast once in three months on such dates as the Secretary with the concurrence of the President may appoint and on such other dates as may be necessary. In the absence of the Secretary and Joint Secretary the President may call a meeting as and when necessary.

The Secretary in consultation with the President may, however, call an emergent meeting of the Board whenever necessary. Five days notice shall be considered adequate for such emergent meeting.

(ii). The President and in his absence the Vice-President shall preside at all meetings of the Board and in the absence of both, the members present shall elect one of themselves to preside at the meeting.

(iii). Notice of not less than two weeks shall be given of the ordinary meetings of the Board and, so far as may be, notice will contain the agenda which shall comprise adequate précis of all items of business to be laid before the meeting. In no case shall the agenda be sent to the members less than ten days in advance of the holding of the meeting, nor shall any defamatory matters be included in the agenda without the permission of the President, nor shall be included in the agenda a motion in regard to the appointment, tenure or condition of the service of any member of the staff without previous written permission of the President. दस दिन के अन्तर से बोला दें।

(iv). Seven, including the office bearers, shall form a quorum for all meetings provided that if there be no quorum the meeting shall be adjourned to a date at least five days of which at least five days notice shall be given to all members. (v). All matters coming up before the Board shall be decided in accordance with majority of the votes of the members present unless otherwise specified and in case of equality of votes the Chairman of the meeting shall have additional or casting vote.

(vi). No matter which has been once considered by the Board shall be proposed for reconsideration without the permission of the President before the expiry of six months from the date of the Board's decision on the matter.

Functions and powers of the Board of Management.

The Boards shall have the following powers and functions:-

- (i). To administer the funds of the Balwant Educational Society and its institutions.
- (ii). To administer the funds and property vested in the Treasurer of Charitable Endowments in respect of which it may be so ordered by the State Government.
- (iii). To make arrangements for funds for carrying on the activities of the Society and for establishing reserve to meet the needs of the Society and its Institutions by all or any of the following means.

(a). By raising subscriptions.

(b) By accepting contributions, Gifts, Grants of all kinds of property.

(d) By starting or carrying on any industrial, manufacturing, Agricultural and Horticultural activities or concerns of institutions, to yield income to replenish or augment the financial resources of the Society.

Provided, secondaly, that the income from the above sources shall be kept and spent only for the educational purposes of the Society.

(c) To acquire property, moveable and immovable for the benefit of the Society or its Institution and to sell any of the properties of Society and its institution at a profit which is considered to be good profit, in the particular circumstances, or even at a loss when the property is not suitable to the needs of the Society and its Institution and the disposal is considered to be in the interests of the Society and its institution.

Provided (a) such decision is supported by at least 2/3 of the members present at the meeting and (b) such purchase or sale shall not be undertaken as a business.

To close down, slow down, re-start, extend, upgrade, transfer from one place to any other place in uttar pradesh any of its activities, Institution, and concerns provided that action is not inconsistent with the will or codicil of the late Raja Balwant Singh.

(v). To take all actions, measures, and steps which may be necessary, suitable appropriate or called for.

(a). achieving any of the objects of the society.

(b). carrying out any scheme, or working a plan in aid of achieving any of the objects of the Society, or

(viii). To arrange for audit and publication of the account and a report of the working of the Society during the year.

- (ix). To sanction expenditure and cause to be included in the budget such emergency items of expenditure not provided for in the Budget as may arise from time to time.
- (x). To fix Hostel and other fees not fixed by the Government or the University.
- (xi). To appoint, dismiss, suspend or punish as the case may be or grant leave of absence to all teachers and other employees of the Society and Institutions directly managed and controlled by the Society, to consider Inter-Institutional transfer of teachers and employees when so requested by them and feasible.
- (xii). To frame from time to time such by-laws or schemes of administration not inconsistent with these rules, as may be necessary for the better Management of the Society or any of the Institution under it so as to conform to the requirements of the University, Board of High-School and Intermediate Education & any other public body to which any of the Institution may be affiliated and to alter or amend the same.
- (xiii). To elect the members to the Managing Committees of different Institutions of the Society as per provisions of their respective schemes of Management approved by the Board provided that the Secretary of the Society shall be among the members so elected, and
- (xiv). To give such directions and ~~orders~~ as may be required in all other matters not expressly so mentioned before.

- (2). All powers hereby vested in the Board of Management may in case of emergency be exercised by the Secretary with the concurrence of the President subject to the approval and control of the Board at its next meeting without prejudicing the validity of any action already taken.

(3). All suits by or against the Balwant Educational Society shall be filed in the name of the Secretary of the ~~Society~~ who shall also have the right to execute all agreements on behalf of the members of the Board of Management including the agreements in favour of Central or any State Government or any other body or authority in respect of any grants, donations, loans etc received from them.

Committees:-

(i) The Finance and the Planning Committees shall consist of :-

(1) The President (2) The Secretary (3) The Joint Secretary if any, (4) Four members nominated by the Board of Management. The President shall preside over the meetings of these Committees, if he is present.

(b) Three members shall form the quorum provided that at least one of them is not an employee of the Society.

(c) The function of the Finance Committee shall be :-

(i) To scrutinise and recommend the annual budget for sanction by the Board of Management.

(ii) To sanction expenditure and payment as provided for in the Budget, and

(iii) To recommend to the Board of Management such emergency items of expenditure not provided for in the Budget as may arise from time to time.

(iv) The function of Planning Committee shall be to scrutinise all plans and schemes for the development of the Institutions and to make recommendations to the Board of Management.

(v) (a) The Appointment Committee shall consist of :-

(1) The President (2) The Secretary (3) The Joint Secretary, if any (4) three members nominated by the Board of Management from among themselves. The President shall be the Chairman.

(b) Three members shall form quorum provided that at least one of them is not an employee of the Society

(c) The function of this committee shall be to interview, select and recommend candidates for the various appointments under the Society.

(iv) All the decisions of the various committees shall be placed before the Board of Management at the next ensuing meeting of the Board, provided that all unanimous decisions of the committee mentioned above may be given immediate effect.



Appointment:-

All appointments to class IV posts shall be made by the Honorary Secretary in consultation with the respective Heads of the Institutions.

(ii) Appointments to all other permanent posts shall be advertised and shall be made by the Board of Management on the recommendation of the Appointment Committee.

(iii) The Secretary on the recommendation of the Head of the Institution concerned shall have power to make temporary appointments for a period not exceeding six months and report the same to the Board.

II. Financial Arrangements.

(i) All money that may be received for the Society and the Institution shall be deposited in the State Bank of India, Agra branch or any other scheduled bank named by the Board and shall be disbursed by cheques to be signed jointly by the Joint Secretary and the Secretary.

(ii) All donations and other income or property given to or received by the Society for any specific purpose shall be appropriated for the said purpose alone.

- (iii) The Secretary shall have power to sanction expenditure within the amount approved in the budget.
- (iv) All payments exceeding Rs. 500/- shall be made by cheque as far as possible.
- (v) Quotations shall ordinarily be invited for the purchase (or sale) of Scientific Apparatus and similar material valued at Rs. 1000/- or more and tenders shall be invited for the undertaking of any construction or repairs, costing Rs. 2500/- or more unless it is considered desirable and advantageous by the Board of Management to undertake any construction or repairs on daily wages.

12. Power of Heads of Institutions:-

The Heads of Institution shall have absolute power in all matters relating to the admission, Promotion and expulsion of students, the discipline of the classes and the collection and remission of fees.

They shall be solely responsible for fixing the hours of study, for the giving and refusing of holidays, for regulating the details of the courses of studies, and for the grant of Scholarships so far as is consonant with the requirements of the Departments of Education, U.P., Departments of Technical Education, U.P., and the B.R.Ambedkar University Agra or the specific byelaws of the schemes of the Board of Management.

- (vi) The Principal of the R.B.S. Inter College shall provide facilities for practical training of the students of the Department of Education of the R.B.S. College, Agra.

13. Hostels:-
